PJWC Concessionaire Application
PLEASE READ CAREFULLY

I / We _____ agree to all of the conditions of this concessionaire application as listed below:

- 1) Concessionaire will pre-pay \$225 for a 10x10 space or \$350 for a 10x20 space, each cart has a fee of \$225. Concessionaire fee must be paid upon acceptance as a food vendor.
- 2) Pay 25% of GROSS REVENUES generated by the show to the Plantation Junior Woman's Club Foundation (PJWC). This figure will be determined by the tickets/computer receipts turned into PJWC throughout the show.
- 3) All purchases for all food and beverages will be made by tickets only. No cash will be accepted. ANYONE ACCEPTING CASH WILL BE ASKED TO LEAVE THE EVENT, NO REFUND OF FEES WILL BE GIVEN.
- 4) We will adhere to all the rules, regulations and fees of the Department of Business Regulation.
- 5) I/We will be covered by \$1,000,000 of Recovery Liability Insurance.
- 6) I/We will include a copy of my/our license and insurance and name the Plantation Junior Woman's Club and an additional insured for the dates of November 13, 14 & 15, 2009.
- 7) Prior to the event, I/We will provide a completed IRS for W-9 to PJWC.
- 8) Ice will be available at a nominal charge to food vendors.
- 9) At each days end, all vendors are responsible for cleanup using the provided trash containers in the park. All sites must be kept clean and tidy at all times during the event. IF YOU USE OILS OR GREASE IN THE COOKING PROCESS, YOU WILL BE RESPONSIBLE FOR DISPOSAL OF THESE PRODUCTS. ABSOLUTELY NO DUMPING OF THESE MATERIALS IN THE PARK.
- 10) NO SUBSTITUTIONS OR PRICE CHANGES WILL BE PERMITTED FOR THESE ITEMS WHICH YOU HAVE BEEN APPROVED TO SERVE WITHOUT THE WRITTEN APPROVAL OF PJWC CHAIRWOMEN.
